1. If your taxes are paid through escrow (Mortgage Company, Savings and Loan Bank) it is your responsibility to forward this bill to your agent.
2. If you have sold this real estate, kindly mail this bill to the new owner.
3. The Tax Collector will not be responsible for payment on wrong tax bills. Payment cannot be removed. No exceptions.
4. All payments made after installment due dates must be made in the Treasurer's office or online. Banks cannot collect delinquent tax.
5. Failure to receive a tax bill will not relieve the taxpayer of penalties accruing if taxes are not paid before the penalty date.
6. Penalty Date & Interest: Payment due on or before due dates shown on front.  
**Real Estate** - Interest added at 1 1/2% per month, or any fraction thereof, after penalty dates until tax is sold or forfeited. A \$10.00 cost will be added for advertising each delinquent tax.  
**Mobile Home** - Interest of \$25.00 per month for each month delinquent following the due date. Interest will be added up to a maximum of \$100. A \$10.00 cost will be added for advertising each delinquent tax.
7. Be sure to enclose the installment payment stub with your remittance to ensure proper credit.
8. N.S.F. Check: Receipt void of payment made by check which is not honored by the bank. A charge of \$30.00 will be charged by the Collector for any check not honored by the bank.
9. Check your tax bill for owner occupied and senior citizens exemptions. If you qualify but have not received credit, call or visit the Supervisor of Assessments in the Joseph G. Cannon Building, (217) 554-1940 option 4.
10. Name and Address Changes: call the Supervisor of Assessments, (217) 554-1940 option 4.
11. The Tax Collector ONLY COLLECTS YOUR TAXES and IS NOT RESPONSIBLE for your tax assessment or the amount of tax you are paying. As a public office, we will continue to assist you and direct you to the proper authority if you have questions regarding your assessment or tax bill.
