- 4. All payments made after installment due dates must be made in the Treasurer's office or online. Banks cannot collect delinquent tax.
- 5. Failure to receive a tax bill will not relieve the taxpayer of penalties accruing if taxes are not paid before the penalty date.

Penalty & Interest: Payment due on or before due dates shown on front.
Real Estate - Interest added at 1 1/2% per month, or any fraction thereof, after penalty dates until tax is sold or forfeited. A \$10.00 cost will be added for advertising each delinquent tax.
Mobile Home - Interest of \$25.00 per month for each month delinquent following the due date. Interest will be added up to a maximum of \$100. A \$10.00 cost will be added for advertising each delinquent tax.

- 7. Be sure to enclose the installment payment stub with your remittance to ensure proper credit.
- 8. N.S.F. Check: Receipt void of payment made by check which is not honored by the bank. A charge of \$30.00 will be charged by the Collector for any check not honored by the bank.
